**Amendment of Declaration No. 047 MOC/SM 2013 on Price Sticker**

**On Commodities & All kind of Services**

- Have seen the Constitution of Kingdom of Cambodia,
- Have seen the Royal-Decree No. NS/RKT/0913/903 dated September 24, 2013 on the Appointment of Royal Government of Kingdom of Cambodia,
- Have seen the Royal-Decree No. NS/RKT/0416/368 dated April 04, 2016 on the Amendment of Supplement of component of Royal Government of Kingdom of Cambodia,
- Have seen the Royal-Krame No. 02/NS/95/ dated July 20, 1995 promulgated the Law on the Organization and Functioning of Office of Council of Ministers,
- Have seen the Royal-Krame No. NS/RKM/0196//16 dated January 24, 1996 promulgated the Law on Establishment of Ministry of Commerce,
- Have seen Sub-Decree No. 131 OrNkr.BK dated March 19, 2014 on the Organization and Functioning of Ministry of Commerce,
- Have seen the Royal-Krame No. NS/RKM/0600/001 dated June 21, 2000 promulgated the Law on Commodity Quality & Safety Management and Services,
- Have seen Sub-Decree No. 68 OrNkr.BK dated December 21, 2012 on the Services Providing to the Sub-National Administrative,
- Declaration No. 1643 SHV.BrK dated December 16, 2014 of Ministry of Economic & Finance on the Bonus to Ministry of Commerce and Ministry of Economic & Finance,
- Declaration No. 266 SHV.BrK dated August 08, 2016 on the Delegation of Power of Management in order to issue the permit on Price Sticker of Foreign Currency to Provincial-Municipal Department of Commerce,
- Declaration No. 047 MOC/SM 2013 dated January 23, 2013 on the Price Sticker on the Commodities and All Kind of Services.

**IT'S HEREBY DECIDED**

**Article1:** To be determined to stick the price on the commodities and all kind of services that have been operating in all of the market in order to ensure the mechanism of the free market development, fair competition and in order to enhance the domestic currency transaction (Riel currency) in aiming for serving to interest of people and public consumers.

- Article2:** Businessman, Traders and all kind of services that have been operating a businesses and services in the Kingdom of Cambodia should be stickered the price on its commodities and services as necessary in Riel currency.
- Article3:** In case of business location and services under duty free that granted an approval from Royal Government, it is necessary to stick the price in foreign currency, businessman, trader and services will be submitted for the permit from Commerce Department of Provincial-Municipals that located in.
- Article4:** Sticker Permit in foreign currency has a validity in one year. The permit renewal will be submitted to the Commercial Department of Provincial-Municipals again before expiration.
- Article5:** The form for foreign currency as below:
- Application form for sticker of foreign currency = 01set
  - Certificate of Incorporation or other permit = 01set
  - Id Card (Khmer) Passport (foreigner) = 01set
  - Patent (last one) copied = 01set
  - Photo (4 x 6) = 03pcs
- Article6:** Businessman, Trader and All Kind of Services who is owner of duty free shop that received a sticker permit in foreign currency should be had a duties to pay the public service to the government as stated in public service in annex of Joint-Declaration of Ministry of Commerce and Ministry of Economic & Finance.
- Article7:** All businessman, Trader and services who defaulted to comply with this declaration will be responsible with Law came into force.
- Article8:** Department of Private Sector Development, CAMCONTROL and Commerce Department of Provincial-Municipals should be collaborated with competent ministries/institutions to control and advice to stick the price on the commodities and service for every month.
- Article9:** Any declarations and provisions that contrary to this declaration will be abrogated.
- Article10:** Bureau Directors, General Directors, General Inspectors, Department Directors, Commerce Department of Provincial-Municipals and relevant Department Director should be carried out this declaration from the signing date.
