INVITATION FOR BIDS

Deadline for Submission of Bids: 16 December 2022, 10:00 am (local time)

1. The Kingdom of Cambodia has received financing from the Asian Development Bank (ADB) towards the cost of Fourth Greater Mekong Subregion Corridor Towns Development Project. A portion of this financing will be applied for eligible payments under the contract named above.
2. The Ministry of Public Works and Transport (MPWT) ("the Employer") hereby invites sealed bids from eligible bidders for the construction and completion of the following contract package.

3. The Works include:
 - Upgrading of 2,218 meters of the external access road to the landfill site to be above flood levels.
 - Construction of one controlled landfill cell out of a total of three cells.
 - Construction of one hazardous waste landfill cell.
 - Construction of a non-mechanical type material recovery facility (MRF).
 - Construction of a covered compost processing facility.
 - Construction of drainage, leachate collection, treatment, and recirculation system.
 - Construction of weighbridge, office, staff dining and restroom (combined building).
 - Construction of workshop, electrical and mechanical room
 - Construction of a supply building.
 - Construction of 1,244 meters of concrete internal roads, with associated bunds and drainage.
 - Construction of wire mesh fencing, brick entrance wall, gate and security guardhouse.
 - Construction of car/vehicle washing facility.
 - Construction of hazardous waste storage building.
 - Provision of utilities, including the construction of a grid-tied solar system.
 - Provision of operations and maintenance

(O&M) equipment (separate from the landfill project).

4. International Competitive Bidding will be conducted in accordance with ADB's Single Stage One-Envelope Bidding Procedure with post Qualifications and is open to all bidders from eligible countries
5. Eligible Bidders must meet the qualification criteria in the bidding documents, including but not limited to:
 - (i) The bidders' net worth within last year shall be positive.
 - (ii) Minimum average annual construction turnover of **US\$10.50 million** calculated as total certified payments received for contracts in progress or completed, within the last three (3) years.
 - (iii) The bidder must demonstrate that its financial resources defined in FIN - 3, less its financial obligations for its current contract commitments defined in FIN - 4, meet or exceed the total requirement for the Subject Contract of **US\$1.31 million**.
 - (iv) Participation in at least one contract that has been successfully or substantially completed within the **last five (5) years** and that is similar to the proposed works, where the value of the Bidder's participation exceeds **US\$6.00 million**. The requirement of working experiences is detailed in Section 3: Evaluation and Qualification Criteria, Paragraph 2.4 Construction Experience of the Bidding Document. The qualification criteria are more completely described in the Bidding Document.

7. To purchase a complete set of Bidding Documents in English, eligible Bidders should submit a written application to H.E. Vong Pisith, Project Director at the address under para. 6 above requesting for the Bidding Documents and upon payment of a non-refundable fee of US\$250 or its equivalent in Cambodian Riel being 1,000,000.00 Riel.

The method of payment will be in cash or deposit to Bank account No.000000001333 of National Bank of Cambodia. The Bidding Documents may be collected in person, or may be sent by email or courier, at the discretion of the bidder, but the Bidder has to deposit the fee at the above bank account and to pay for courier charge by his/her arrangement as appropriate. Other than payment of the non-refundable fee, there shall be no other conditions for the purchase of the bidding documents.

The Bidding Documents can be purchased during normal working days from between 8:00 am – 11:30 am and 2:30 pm – 5:00 pm at the address under 6 above, from **04 November 2022**.

8. Bidders should deliver their bids:
 - (i) To the address given under item 6 above **on or before the deadline: 10:00 am (local time) on 16 December 2022**.
 - (ii) Together with a Bid Security in the amount as specified in the Bidding Documents. For the purpose of determining the equivalent amount of the required Bid Security in a freely convertible currency, the selling exchange rate published by the National Bank of Cambodia on the date 28 days prior to the deadline for Bid submission shall be applied.

Bids will be opened immediately after the deadline, in the presence of Bidders' representatives who choose to attend.

The Bidder shall bear all costs associated with the preparation and submission of its Bids and the Employer shall not be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.
